1.Role Description:


This position is responsible for managing the operations of the Banks legal Office and providing expert legal advice across the Bank. The incumbent will ensure comply with national and international legal framework, including Anti-Money Laundering and Counter Financing of Terrorism (AML/CFT) standards. More so, supports Corporate Strategy, regulatory monitoring, and engagement with stakeholders to safeguard the integrity of PNGs Financial system.

2. Responsibilities

- Coordinate Risk Management and Provide Legal Support
- Contribute as appropriate to the performance of other functions and to the overall achievement of BPNG's strategic Objectives.

3.Requirements

- Education: The incumbent must hold a Master Degree in Law from a recognized University; be admitted as a Legal Practitioner to the national and Supreme court of Papua New Guinea and holds Current practicing certificates to practice in Papua New Guinea
- Experiences: Professional experience of ten (10) or more years on post admission practice as a lawyer in Commercial Law and a Litigation Legal Services, managing bank's risk, knowledge to deliver accountabilities and demonstrate the requisite competencies and values of the positions. Knowledgeable in corporate governance principles, legal requirements and regulatory framework.
- Professional/Technical Skills/Attributes: The GC must possess intermediate Technical skills in Compliance/Legislation, Contract management, Industry Knowledge, Negotiation, People management Process, knowledge in drafting Legal Documents, knowledge in Civil Litigation, Commercial Law such as Conveyance, Alternative Dispute Resolution and Criminal Litigation. The prospect candidate must have excellent communication skills, planning and organizational skills, be result oriented, provide work of high quality and demonstrate drive and determination to maximize own performance while being result oriented and work collaboratively as part of the Department team to deliver the accountabilities of the position.
